

**PROTOCOL
on cooperation
between**

Moscow region state university
and
The Russian-Indian Friendship Society "DISHA»**

Striving for the development of friendly relations between our peoples, taking into consideration the mutual interest in the field of higher education, science and culture, the State educational institution of the Moscow region higher education Moscow region state university (hereinafter MRSU) in the person of Dr. Veronika Zapalatskaya, the Caretaker Rector, acting on the basis of the Order No. 161-k dated June 19, 2018, and the Russian-Indian Friendship Society "DISHA" in the person of Dr. Rameshvar Singh, the President, acting on the basis of the Charter, hereinafter referred to as the Parties, concluded this Protocol on the following::

Article 1. Subject of the Protocol

1.1. The cooperation in the field of development of relations between state, public, educational and scientific institutions of Russia and India is the subject of this Protocol.

Article 2. Main areas of cooperation

2.1. Managing and executing of the joint cultural, educational, scientific and other events targeted towards the development of relations between the state, public, educational and scientific institutions of Russia and India, as well as the peoples of both countries at large.

Article 3. Financial relations between the Parties

3.1. All issues related to possible financial relations of the parties are stipulated in separate agreements.

Article 4. Special conditions

4.1. Amendments and additions to this Protocol are the subject to the Parties' consent, and shall be made in the form of a new Agreement and/or Supplementary Agreements.

4.2. This Protocol may be supplemented by the Additional agreements specifying the areas of cooperation, determining the conditions for the development and implementation of educational and scientific activities, projects and programs.

4.3. Additional Agreements are to be signed by the leaders of the Parties on the basis of the Parties' Charters.

4.4. In the event of an intention to terminate the Protocol, the Party initiating the termination shall notify the other party at least sixty (60) days prior to the date of the supposed termination. At the same time, the parties shall complete the work on the implementation of previous commitments within the terms established by this Protocol, relevant Supplementary Agreements.

Article 5. The duration of the Protocol

5.1. This Protocol is made in accordance with the legislation of the Russian Federation and consists of two copies in Russian and two copies in English. One copy in both languages for each party. All copies of the Protocol shall have equal legal force.

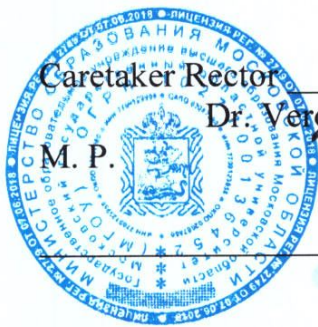
5.2. This Protocol is valid for 5 years from the date of signing.
