### Partnership Agreement

Non-governmental autonomous non-profit organization of higher professional education "Institute of World Civilizations", hereinafter referred to as "IWC", represented by Rector Alexander Streltsov, on the one part, acting under the Charter, and, non-commercial partnership "Russian-Indian Friendship Society", referred to as "DISHA", represented by President Dr. Rameshwar Singh, on the other part, acting under the Charter, hereinafter referred to as the "Parties", have agreed the present Agreement as follows:

#### 1. Description of the Agreement

The subject of the Agreement is cooperation in education and science, assistance in promotion effective functioning of postsecondary and postgraduate educational systems, preparation of highly qualified specialists and highly qualified research personnel, constant skills development of workers, integration of professional education and science, development of cultural relations between the Russian Federation and India.

# 2. Main cooperation areas

- 2.1. The main areas of cooperation between the Parties are:
- 2.1.1. Realization of joint scientific practical and methodical symposiums, conferences, round-table discussions, seminars;

Student exchange of undergraduates, graduates and postgraduates, arrangement of practical trainings;

Assistance in the establishment of DISHA cultural centers of Russian-Indian friendship in Russia and India.

- 2.1.2. Assistance in information distribution about IWC, trainings, forms and conditions of studying in IWC and learning opportunities in IWC for Indian and Russian citizens;
- 2.1.3. Information exchange about training programs in IWC considering postsecondary education (all levels of higher education), postgraduate education, additional professional trainings;
- 2.1.4. Preparation of joint research monographs, scientific and methodical publications, popular science publications, articles, etc.

- 2.1.5. Participation in joint scientific practical and methodical symposiums, conferences, round-table discussions, seminars on current research problems, implemented by the Parties;
- 2.1.6. Academic teacher and specialist exchange in educational and research programs, giving lectures, and the research work based on mutual interest;
- 2.1.7. Student exchange of undergraduates, graduates and postgraduates, arrangement of practical trainings;
- 2.1.8. Experience exchange in organization and methods of training, using educational technologies;
- 2.1.9. Realization of joint scientific and educational projects and programs. Joint research and other activities of the Parties, directed on providing scientific solutions of the major problems of the education system;
- 2.1.10. Student, graduates and postgraduates involvement to the scientific research work in fundamental and applied studies.
- 2.1.11. Development and implementation of vocational competence of teachers and working personnel and employees of IWC. Implementation of joint projects, courses, seminars of training, retraining and advanced training of specialists;

### 3. Obligations of the Parties

- 4.3. Within the realization of the Agreement, the Parties are to protect the rights of intellectual property results.

- 4.2. The present Agreement is made without any mutual financial conditions of the Parties. The financial conditions are to be specified in additional contracts.
- 4.3. Within the realization of the Agreement, the Parties are to protect the rights of intellectual property results.

- 4.4. Any changes and amendments of the Agreement conditions are to be made in the forms of additional agreements and become effective from the moment of signing by both Parties.
- 4.5. The present Agreement is operative from the moment of signing and valid for three years. If neither Party notifies its desire to terminate this Agreement, before the expiration of the above period of time, the Agreement is to be extended for another term.
- 4.6. The present Agreement is made in two copies, valid equally, a copy for either of the Parties.
